



THEN

1930s-1980s.

- Quarry mining, truck terminals, sandblasting operations, automotive repair and chemical manufacturing
- Contaminants included: petroleum hydrocarbons, chlorinated solvents, PCBs, coal slag

"The site was contaminated enough that it would have fallen under other mandatory provisions for cleanup had Ryan not agreed to take part in the cleanup. At the time, MPCA didn't have enough money to go into all such areas destined for Superfund status and clean them up. The Quarry would have been given Superfund list priority had Ryan not made the deal. 


